Total credit outlay available under AHM for allotted stations is INR 3,672 Crores (\$446 million USD) for seamless expenditure during the construction phase of 121 stations, spread over 36 months, amongst 3 phases with 12 month moratorium period for each phase to complete land acquisition, construction, installation and handover to the allottee PSU or private entity in PPP mode under Annuity Hybrid E-Mobility (AHM) funding model of National Highways for EV.
